

**RULES AND GUIDELINES FOR THE SUBMISSION OF ENTRIES
FOR THE EDIPUGLIA 'RENZO CEGLIE' AWARD
4th EDITION - 2020**

- Attendance is open to all Italian and foreigner authors, who are younger than 40 years-old at the delivery date.
- The entry should be an original work, in the fields of studies specified in the section 'Regulation' ([link](#)), and must be submitted within **June 30th, 2020**.
- The essay must not exceed 200 pages (400.000 characters – spaces included) and should include no more than 50 images.
- The essay should be edited as a monography and must comply with the editorial standards provided by the Editorial Board [here](#). Variations or exceptions will be evaluated by the Jury.
- Every author can submit one and only entry.

HOW TO SUBMIT YOUR ENTRY:

- a) a hardcopy of the entry + registration form + *Curriculum Vitae* must be sent by postal service to the following address: "Premio Renzo Ceglie" - Edipuglia via Dalmazia 22/B, 70127 Bari-S. Spirito. Application must be postmarked by **June 30th, 2020**.
- b) a PDF file of the entry + registration form + *Curriculum Vitae* must be sent by email to redazione@edipuglia.it by **June 30th, 2020**.

THE JURY:

Jury is formed by members chosen among directors and authors of the Edipuglia series (prof. Carlo Carletti, Rosalba Dimundo, Marcello Marin, Giorgio Otranto, Saverio Russo, Marina Silvestrini, and Giuliano Volpe, who is the president of the commission). External referees, Italian or foreigners, can be also asked to review the entries. Based on the commission's evaluations, a merit ranking will be published together with the minutes of the Commission on Edipuglia website.

PLEASE, NOTE THAT:

- Submitted entries will not be returned at the end of the contest; all hardcopies and pdfs will be destroyed to protect copyright.
- At the end of the contest, the list of all participant will be published on the website of Edipuglia (www.edipuglia.it), in the section of the Premio Renzo Ceglie together with the merit ranking and the name of the winner. Omissions or misprints can be reported to the secretary within one week after the publication of the minutes of Commission.
